## President's Report

At the October 16th Board Meeting, the Board unanimously approved sending the proposed 2015 budget to owners. typical owners' meeting for discussion of the budget will take place as usual at 6:30 pm immediately before the regular November 20th board meeting when the new budget will be adopted. However, this year we will also be holding an owners' town hall meeting on Wednesday, November 12 at 7 pm where details of the 2015 budget will be explained and questions will be answered.

This budget is the result of many months of careful assessment of the critical needs of our 52 year old structure by our Buildings and Grounds Committee who then worked with the Budget Committee on a plan to meet these critical needs. Our Property Manager, Bill O'Leary, worked with the committees throughout these long processes. Many owners were involved in drafting the budget that was unanimously approved to be recommended to the Board for distribution to owners. The Board then unanimously approved its distribution to owners. The most important objective of all those involved in the budget process is the careful, reasonable and responsible care of Marina Towers. All of those involved with this budget take their responsibility very seriously and are passionate in their desire to properly care for Marina Towers. owe our thanks to all of the members of the both the Budget and the Buildings and Grounds committees and to Bill O'Leary for the many hours of work they devoted.

The Board also approved the following at the October meeting:

- Holiday Party to be held on December 15th. The plan is similar to last year's party which was a huge success and was also a much reduced cost from previous years.
- 2014 refuse reimbursement from the City of Chicago.
- Expenditures related to Life Safety Ordinance requirements, exterior facade inspection, west tower plaza doors replacement and roof repairs.
- Payment to Thompson Coburn for their legal services in obtaining a reduction in our real estate taxes. The Association had retained this firm when our real estate assessed values for 2013 were greatly increased, resulting in a greatly increased tax bill for each condominium unit. This firm was successful in obtaining a total tax reduction of \$227,071.25. This reduced each owner's property tax bill by an average of \$253.43 per unit.

Marina City is among ten of Chicago's most iconic buildings that are featured on the Chicago Architecture Foundation's newly launched Skyline Stories, a digital showcase of Chicago's most iconic buildings. There are four short video clips on Marina City. These wonderful videos were produced this year and have just been released. The videos featured answer question such as: Have you ever looked up at a building and thought, how was that designed? What was the architect thinking? Or why was it built in Chicago? The answer to these questions and many more are revealed in the stories presented on Chicago Architecture Foundation's Skyline Stories. ### <u>Treasurer's Report</u>

As of the end of September, MTCA had \$2,381,000 in reserve accounts. As invoices for various Life Safety projects are paid, reserves are expected to end the year at \$2,100,000.

### **Buildings and Grounds Committee**

The Buildings and Grounds Committee has finally worked out the last details for the bids on the air conditioner replacements. We sent our requirements to nine companies around Chicago to give us prices on installing the new units. By this time next month we will have several bids to choose from and hopefully we will have a contractor on board. The work will take place over the winter. Our requirements for all the bidders were that the work be completed by the end of February so that we have plenty of time to make sure the air conditioners are up and running by the time hot weather arrives again.

## Liaison Committee

The committee met on October 7th and discussed the success of the Flu Clinic (see report below) and the pending opening of the new grocery store. A viable and thriving grocer is vital to the health of Marina City and is of substantial benefit to the residents of the complex. That being said, the committee has invited the owner of the grocery store to our next meeting which will be held at 2PM on November 4th in the "old" meeting room next to the office.
